- If one is not involved in this 'Sector' we would initiate shorts





Ratio Chart: AAPL-MSFT 2-Stock Equal Weight Basket/S&P 500 Index






Ratio Chart: AAPL-MSFT 2-Stock Equal Weight Basket/S&P 500 Index






Ratio Chart: AAPL-MSFT 2-Stock Equal Weight Basket/S&P 500 Index
