Consider the sharp contrast between the 2 baskets in this report:

BASKET 1: An equal-weighted '50-stock basket' of S&P 500 stocks whose price action (absolute and relative) is **very good**, of late...

BASKET 2: An equal-weighted '50-stock basket' of S&P 500 stocks whose price action (absolute and relative) is **very poor**, of late..

We favor the stocks in BASKET 1 vs the stocks in BASKET 2; we want to be long BASKET 1, short BASKET 2.
